Let Me Count the Ways I Can Support PLC

1. **Sunday envelopes** – traditional way. Requires you to remember to write a check or have cash each week. Easy to forget if you are on vacation or miss a Sunday.



2. Automatic withdrawal from you bank/checking account - VANCO. Simple and easy way to



tithe. Fill out a one-page form, indicated amount and when you want it withdrawn (weekly, bi-monthly, monthly, etc.) and it will happen automatically. Forms can be requested from Glenna or sent an e-mail to Treasurer@plc.cc.

4. Thrivent Choice Dollars – for those who have eligible financial accounts at

5. Qualified Charitable Distribution (QCD) – Using a QCD is a tax-savvy strategy that allows you to transfer up to \$100,000 per year from your IRA directly to a qualified charity. It is only available to IRAs and individuals who have reached Required Minimum Distribution (RMD) age of 70 ½. Any amount processed as a QCD counts toward your RMD requirement and reduces the taxable amount of your IRA distribution.



requirement and reduces the taxable amount of your IRA distribution. This lowers both your adjusted gross income and taxable income, resulting in a lower overall tax liability. For example, if a 70-year-old couple, who have an annual RMD between the two of them of \$24,000, can instead direct \$10,000 of it to charity as a QCD, it will reduce their taxable income by \$10,000 and they still get to claim the same \$26,550 standard deduction in 2018. In this case, if the couple is in the new 24% tax bracket, by using this strategy, they would have saved \$2,400 in federal taxes alone — and potentially more in state tax savings. This is good reason to perform a QCD if you plan to take the standard deduction in 2018, which is why this strategy will likely become commonplace in 2018. Please discuss this strategy with your accountant to make sure it works to your advantage.
